What's up Siblings? In today's issue we will report on Interviews, Labor Day, actions by NUHW and UFW and a gauntlet is thrown. For the past two weeks Labor Affiliates have been meeting at the Sheetmetal Workers #104 Training Center to conduct interviews for the Nov. 8th general election. Over 20 affiliates participated in the process for candidates that did not receive an early endorsement in July, with 58 candidates appearing before the panel of leaders, who deliberated and came up with recommendations to the Building Trades and Central Labor Councils who ratified their endorsements at their delegates meeting. We want to thank all of the candidates who respected the working families in Napa and Solano Counties by appearing and allowing our members to question them on their values and vision they share with our members. Now we will come together and work to share those values and vision with our members and the citizens. Look for ways that you can assist in helping get them elected by visiting our web page.

Labor Day is two weeks away, so if you have not sent in your sponsorship or bought your ticket you better do it now. We will come together at the Ironworkers Local #378 in Benicia and enjoy breakfast burritos prepared by the Operating Engineers Local #3 and cold beverages provided by IBEW Local #180 followed by good ole fashion speechifying by our special guests. This year we are proud to have the California Labor Federations new leader Lorena Gonzalez Fletcher who, along with our Congressmen, Senate and State Assembly members will help us celebrate the sacrifices of those who came before us and the future warriors of the Labor Movement.

We are also following two specific actions Nation Union of Healthcare Workers and and the United Farm Workers. The Farmworkers are marching to the State Capital to urge the Governor

to support them in the same manner they supported him during the recall: by allowing them to organize and vote by mail! We will meet on the 26th a few blocks from the Capitol and join UFW members who have been marching up the coast for two weeks.

At Kaiser Hospitals in Vallejo and Vacaville, NUHW mental health workers are striking for better patient care and we are urging our Siblings and elected official to join us Wednesday and Thursday to show our support.

Last edition, we covered AB 257 which is a Bill of Rights of sorts for the fast food industry. SEIU is organizing support for the Bill and are asking us to contact Bill Dodds office to urge his support.

Melvin Breshears from the Insulators Local #16 has thrown down the gauntlet to all able-bodied Siblings to get off of their a\$\$#\$ and get a whaleboat team! As defending champions of the Labor Division of the Whaleboat Regatta at the Vallejo Waterfront Weekend he added that while it won't make a difference in the outcome, striving for second place is still a noble goal for you and your members. All you need are 8 Sibs with strong backs, maybe weak minds, and the urge to move heavy objects for no apparent reason, to sign up. You only have to show up and the Whaleboat Club will provide the training and coxswain to steer the boat.

Napa-Solano CLC Candidate Endorsements General Election 2022

We will be talking with workers and members of the broader public as we fight to establish governing majorities who are ready to pursue growth that uplifts and empowers all workers and their communities alike.

Inflation Reduction Act – Workers, Environment, and Health Care

Over the past week, President Biden signed into law the historic Inflation Reduction Act. This legislation is the largest single effort yet by the Federal Government to combat climate change, while expanding health care access and affordability amidst further investment in infrastructure.

This legislation developed over the past year from the earlier efforts for the Biden Administration's Build Back Better agenda. Fundamentally, this legislation achieves the following-

- Significantly invests in renewable energy, largely via tax credits, as well as tax credits/incentives targeted to individual households to utilize green energy, electric cars, and other energy and water efficiency measures.
- Extends subsidies to Affordable Care Act/Obamacare programs that will enable more people to afford health insurance while enabling Medicare to negotiate and contain costs on certain prescription drugs. Out-of-pocket costs for pharmaceuticals under Medicare Part D will also be limited.
- The establishment of a minimum tax on corporate profits, as well as enhanced IRS enforcement for collecting taxes from wealthy individuals and corporations. This revenue will also achieve some deficit reduction.

There are other provisions, but the picture is clear – major investments in infrastructure, sustainability, and health care are now being achieved for the benefits of workers with this legislation while making corporations and the rich pay more of their fair share. This legislation, totaling \$750 billion, and the Bipartisan Infrastructure Framework from 2021 (\$550 billion in new infrastructure funds) jointly constitute the greatest investment in workers and essential services in many decades. A clear change is now underway in American politics – the increased popularity of unions and pro-working class policies, though the danger of authoritarian and anti-labor movements persist.

From the local perspective, we have an historic opportunity. As we work to build power at the local level through winning elections and building labor-community alliances such as our Community Benefits Coalitions, we are laying the foundations to fight for these federal investments to come to Solano and Napa Counties. By understanding these policies and by building public and political support, we are making a strong case for investment of these resources in our workforces and communities and the opportunity grow the labor movement right here and right now.
