## 2023 - Frontlines for Labor

Following our major victories in the 2022 General Election, we are now moving forward to build worker power as never before in 2023. We encourage each and every affiliate to get involved as we work to open a new chapter for both Counties.

As we build power on all fronts, we will be expanding our new Action Team. This team consists of labor activists committed to helping build a larger volunteer base for labor to both assist unions in need and to push for collective union goals. These actions range from contract fights to supporting striking workers to supporting pro-worker policies in our local governments. When our workers' futures are at stake, we should be the greatest force in the room, whether at a City Council meeting or a public rally. Keep an eye out for updates on Action Team meetings, and we urge all affiliates to check out this great opportunity to advance worker power.

With pro-labor majorities now established in many of our local governments, many of our greatest opportunities now lay in coalition and policy work. This labor council, in partnership with environmental, housing, and other community groups, are driving new agendas with the Community Benefits Coalitions in Solano and Napa. Working together, we intend to redefine growth in our local communities to advance workers across all walks of life, changing both policy and budgets. From the national level, the unprecedented investment from the Bipartisan Infrastructure Bill and the Inflation Reduction Act translates to hundreds of billions of dollars going towards jobs, infrastructure, and essential services. Our coalitions will partner with our allies in local government to make the superior case for funds to be spent into our local community.

At the local level, we will be placing an expanded focus on housing and other economic development plans. Across both Counties, our local governments are updating their Housing Elements, which identify and begin to approach housing needs over the coming years. This is a great opportunity for labor and its allies to focus on expanding workforce housing, enabling housing that is both local and affordable for middle and working-class families. On economic development and following our work establishing pro-labor language in the Napa General Plan, we will next be focusing on the Mare Island Specific Plan. The future of Vallejo runs through the redevelopment of the former base, and the opportunities to create local union jobs are immense.

The coming year will be an exciting one as this labor council and labor movement works to build power on all fronts. The power ultimately comes from all of you as workers, and we encourage every affiliate to jump in. We look forward to seeing all of you on the frontlines!

# Election Summary – Swearing-In Ceremonies

The 2022 General Election contained many great victories for the labor movement. The vast majority of our endorsed candidates and ballot measures have won! We worked to bring the labor movement and its allies together to identify pro-worker candidates and to extensively mobilize to win pro-labor majorities. We can now count upon majorities supportive of workers' issues in both Counties and across many of our cities. As you will see in the Election results at the end of the Newsletter, there were many competitive races, including many decided by a few percentage points or less. Critical races were decided by a literal handful of votes. This means that our affiliates and union members who got out there and helped reached the voters made all the difference. You are the margin of victory!

Our labor champions will be sworn into office at various times and dates over the next month. We encourage members to attend these ceremonies and show our support for them as we prepare to work to advance labor issues in 2023 and beyond.

### Member Spotlight – Tyler Kissinger, Rachel Allen, Guille Gonzalez, NUHW

This has been a busy year for NUHW! As has been all too common, we spent much of it fighting Providence (the corporate owner of Queen of the Valley) to improve patient care and working conditions for staff. But our NUHW union siblings who work at Kaiser Permanente also launched the largest and longest strike of mental health care workers in US history, and we worked to support labor champions running for office in our local community.

Our union is committed to fighting for healthcare for all, and that was why NorCal Kaiser clinicians struck for 10 weeks. Patients regularly have to wait for 6-8 weeks between appointments, and too many of us know someone who has slipped through the cracks and been unable to. The cause of this is Kaiser's short staffing and lack of investment in its mental health care services. Even though Kaiser has something like \$54 billion in cash reserves (more than the state of California), it only employs 1 therapist for every 2600 Kaiser members in Northern California. Therapists knew that was unacceptable, and it's why they struck and won a fair agreement that will improve staffing, working conditions, and recruitment and retention of new therapists. When we fight, we win!

Amidst this, we worked to plug into the work that the Labor Council has been doing to elect labor champions! See below for some testimonials from NUHW leaders and staff (Rachel and Guille).

#### **Rachel Allen**

I worked in Healthcare for 21 years, 16 of which were spent at Children's Hospital in Oakland. The first 10 years or so, my job classification at the hospital was not part of a union, but some of my coworkers in other job classifications were. Seeing the benefits of their union from an outside perspective really opened my eyes as to what could be accomplished if my coworkers and I band together. One day, a NUHW organizer came into the office where I was working and asked if my job classification wanted to organize. Other people were hesitant but I jumped at the opportunity. I took the sign up form and personally went to all of my coworkers, explaining to them what I have seen throughout my years working at the hospital, and the difference the union had made for our other coworkers who were already organized. I convinced an overwhelming majority

of my coworkers to sign up. On the day of the vote, I hid the NUHW director in my office so that my coworkers and I could vote to be part of the union with NUHW. I became a steward and attended many trainings that were offered through NUHW. After 6 years of being a steward, one of the directors reached out to me to see if I'd like an opportunity to organize for NUHW. I jumped at the opportunity, feeling compelled to help those who were healthcare workers like myself. I have been with NUHW for a year now, working with Queen of the Valley Hospital, which led me to the Napa Solano Central Labor Council that I am a proud delegate of.

#### **Guille Gonzalez**

I'm a Community Health Worker at Queen of the Valley, meaning I help residents in our Napa community get connected with services they and their family need to live healthy lives. I'm also an active steward in our union, NUHW.

From when we first formed our union, my coworkers were actually almost not a part of the union: Providence tried excluding us from being a part of the NUHW bargaining unit at Queen of the Valley. That made no sense to me and my coworkers, so we showed up at meeting after meeting until ultimately Providence was forced to agree that we were in the union. From showing up at all of these meetings, I saw the importance of actively participating: I saw the reality behind the misinformation my coworkers and I were exposed to, and understood that in reality, we are the union!

I have always cared about what's going on in my community. Napa is small, so there's no reason not to be engaged in what's going on! As a part of my union, I've actively supported local labor champions, like Scott Sedgley and Joelle Gallagher, because I know they are good people who will partner and be accountable to ordinary working people in our community. I'm so excited that we have so many pro-worker leaders now in office in our county, and am excited to keep working with them through the Labor Council and my union!
